

The Summer Schools of Slavonic Studies offering **Czech language courses** are organised by several public universities in the Czech Republic: **Charles University** (Faculty of Arts, **Prague**), Charles University **Institute for Language and Preparatory Studies in Poděbrady**, **Masaryk University** (Faculty of Arts, **Brno**), **Palacký University in Olomouc** (Faculty of Arts, **Olomouc**), **University of South Bohemia** in České Budějovice (Faculty of Arts, **České Budějovice**) and the **University of West Bohemia in Pilsen**. The courses are held during the summer months (July – September), their length ranges from 2 to 4 weeks depending on the course content determined by each Summer School and are designed for foreign students, teachers, translators and interpreters and other experts active in the field of Czech/Slavonic studies. Due to their broad scope they are, however, open to anyone else who is interested in the Czech language, literature, history and culture. The Summer Schools offer language courses at various levels of proficiency, seminars on the Czech literature, culture and history, free-time activities including theatrical, musical and dance performances, trips etc.

IMPORTANT NOTICE: Greek scholarship applicants **MAY APPLY ONLY** for a SSSS course which will be held at the **FACULTY OF ARTS OF PALACKÝ UNIVERSITY (OLOMOUC)** and at the **DEPARTMENT OF CZECH FOR FOREIGNERS, FACULTY OF ARTS, MASARYK UNIVERSITY (BRNO);** the applicants are supposed to choose one of these two as their preference.



Detailed information on scholarships for Greek citizens to participate in the Summer Schools of Slavonic Studies in the Czech Republic in 2019 and Instructions how to apply

Two scholarships will be granted for Greek citizens to participate in the Summer Schools of Slavonic Studies in the Czech Republic in 2019, in compliance with Article 5b) of the Programme of Educational and Cultural Co-operation between the Government of the Czech Republic and the Government of the Hellenic Republic. One scholarship has been assigned for the Summer School of Slavonic Languages at the **Faculty of Arts of Palacký University in Olomouc** - the course will be held from **20 July 2019 to 18 August 2019**, detailed information can be found on: www.lsss.upol.cz. // The other scholarship has been assigned for the Summer School of Slavonic Studies at the **Faculty of Arts of Masaryk University in Brno** - the course will be held from **20 July 2019 to 17 August 2019**, detailed information can be found on: www.phil.muni.cz/kabcest/en/summer-school.php.

Attention: Only those who will have completed 18 years on the 1st day of the course can apply!

The scholarship covers tuition, board, accommodation and excursions organised as part of the respective summer school course programme. For more information applicants can visit: www.msmt.cz/eu-and-international-affairs/summer-schools-of-slavonic-studies.

The acceptance to the above summer courses follow the international agreements, and hence it is necessary that the nomination of candidates will be done on the reciprocity principle by the respective Greek authorities, which are kindly asked to **have submitted the nominations, consisting of properly completed application forms and other supporting documentation, to the Embassy of the Czech Republic in Athens by 15 March 2019**. In this respect, please, notice that OTHER THAN THE HEREWITH ENCLOSED PRINTED APPLICATION FORM WILL NOT BE ACCEPTED. Prior to application despatch to the Ministry of Education, Youth and Sports of the Czech Republic, **all application forms must be stamped by the Embassy of the Czech Republic in Athens**. Apart from the required obligatory CV, other documents such as cover/motivation letter resuming why applying for a scholarship, certificates on languages skills and educational background are recommended to be part of the application file.

In order to speed up and facilitate the process and further communication, the Ministry of Education, Youth and Sports of the Czech Republic kindly asks the candidates and alternates to **refer their phone and fax numbers and e-mail addresses in application forms**.

Letters of acceptance will be delivered by the respective school directly to the contact addresses of the accepted candidates. **It is absolutely necessary that having received a letter of acceptance accepted candidates will immediately confirm by e-mail and also by a letter to the respective school whether they will participate or not.**
